CORRECTIONS TRAINING ACADEMY

From Interstate 71 take the Orient/Harrisburg exit. Go east (left turn onto Rt. 62) About 300 yards turn left onto Stahl Road (this is tricky, as it appears to go straight where Rt. 62 goes to the right). This takes you through the town of Orient. Follow Stahl Road to the first stop sign - turn left. This street dead-ends into State Route 762 (the Orient Correctional Complex can be seen straight ahead). Take a left onto Route 762, then an immediate right onto the Orient Correctional Complex. At the first stop sign, turn left. You will go up a hill, past a water tower on the left. At the next Stop sign, continue straight and down a hill (past the 2nd water tower on the right) Down the hill, on the right, turn into the parking lot. You have arrived at the main AT Building.

TRAINING AND EDUCATION CENTER (TEC)

From Columbus' West side, take I-70 W towards Indianapolis. Take the OH-56 exit, exit 72, towards London. Turn left onto OH-56. Go about 2.3 miles towards London. The driveway to the institution will be on the right hand side. They share a driveway with BCI and OPO-TA. The institution sits back about ½ mile. As you approach the front entrance to the institution, TEC is located on the left hand side in a separate building outside the main institution. There is a parking lot in front of the TEC building.

APPLICATION PROCEDURES

All DRC employees must register using ELM. All Non-DRC employees can obtain registration instructions by contacting the Program Manager listed for the specific course.

COURSE START TIMES AND LOCATION:

Unless noted, all courses begin at 8:00 A.M. and end at 4:30 P.M. Course locations are listed in the course description.

REGIONAL COURSES

DRC staff attending regional courses that require travel or overnight accommodations must follow OBM travel guidelines. Non-State of Ohio Agencies are required to arrange for their own travel and accommodations. Meals are not provided for regional courses.

DRESS CODE

The dress code for the Department of Rehabilitation and Correction (Policy # 31-SEM-06) is to be followed while at Academy sponsored training. Dress is business casual for Inservice classes that are not physical skills. For physical skill classes, decent jeans and appropriate shirts are acceptable. Shorts are permitted in the gym, but long pants must be worn outside the gym. Physical skills includes Unarmed Self-Defense, Firearms, Chemical Munitions, CPR, Transportation, PR-24 and all related courses such as Response to Sexual Violence/Rape Prevention, Weapons Retention, Officer Down/Ground Confrontation Tactics, etc. during which a student may be required to be on the floor or do exercises that would require different attire.

OVERNIGHT ACCOMMODATIONS AND CHECK-IN

The Corrections Training Academy has on-sight accommodations available for its registered students that meet OBM travel guidelines. Students must bring all towels, wash cloths, toiletries, soap, etc. Sheets and blankets are provided. Check-in is done through the CTA Sergeant or Correction Officer, located in Room 26, in the Main AT (Wilkinson) Building. All personal property must be removed from the room and room keys returned by 8:00 am on the day the student checks out.

NOTE: All DRC facilities, including the Corrections Training Academy, are tobacco free. Tobacco of any type is prohibited on facility grounds.

COURSE PREREQUISITES

All persons applying to attend Corrections Training Academy courses must meet all course prerequisites. Please review prerequisites to ensure compliance prior to registering for any class. A person will be sent back to their work site if they arrive without documentation that shows they have met the prerequisites of a course.

INSTRUCTIONAL SKILLS

Completion of the 40 or 32 Hour Instructional Skills course is required for Instructor courses. If a person takes an instructor course prior to obtaining the 40 Hour Instructional Skills course, their certificate for the Instructor course will be held for up to 1 year until the 40 or 32 Hour Instructional Skills course has been successfully completed. After 1 year, the person will need to re-take the Instructor course.

ADDITIONAL COURSES

Additional courses of instruction may become available throughout the year.

COURSE COSTS AND BILLING : NON-STATE OF OHIO AGENCIES

The basic cost for courses conducted at the Corrections Training Academy is \$40.00 per day and this cost includes onsite meals. Lodging is available for an additional \$15.00 per night and rooms are multiple occupancy. The basic cost for courses conducted at regional locations is \$25.00 per day. Your agency will be invoiced after completion of the course.

The total fee for some courses may be higher due to the cost of course materials. All course fees are listed in the specific course description.

CONTINUING EDUCATION INFORMATION

Certain Mental Health and Medical Health care courses have been designated as eligible for Professional Continuing Education Units and have been noted on the specific course description. Only courses identified as offering CEUs are eligible.

CHANGING OFFENDER BEHAVIOR

Over the past 30 years, considerable research has been developed regarding the prospects for changing criminal behavior. This research has morphed from what was referred to in the 1980s-1990s as “What Works” in corrections to what is now known as Evidence-Based Practice (EBP). Though there are a variety of outcomes that EBP may achieve, much of the research associated with this long-term evolution has centered on the reduction of offender recidivism. This particular metric has been elevated in importance within ODRC given the recently adopted mission of “reducing recidivism in the lives of those we touch.”

For the purpose of training staff, an acceptable curriculum directed at “Changing Offender Behavior” may be defined as one that focuses on effecting sustained behavioral change and the reduction of future recidivism by drawing on EBP-grounded strategies and tools.

EBP STRATEGIES AND TOOLS

Within an EBP framework, one or more key strategies and tools must be incorporated in the training curriculum for it to be recognized as a COB course. The curriculum must:

- (1) Rely on validated risk and needs assessment tools to identify offenders’ risk to reoffend and criminogenic needs.
- (2) Direct programming and interventions to medium and higher risk offenders targeting their dynamic criminogenic needs (e.g., substance abuse, impulsive behavior, criminal peers, criminal thinking). Monitor low risk offenders with a “light touch.”
- (3) Develop more or less intensive individualized case planning for offenders based on the principles of risk management established in (1) – (2).
- (4) Ensure that the programs or treatment interventions are grounded in the principle of responsivity relative to different learning styles, cultural/gender differences, and literacy levels.
- (5) Encourage the recognition and correction of thinking errors, and provide opportunities to practice and role play newly-learned behaviors.
- (6) Use a higher ratio of incentives to sanctions in promoting behavioral change though responses to non-compliance or misconduct should be met with swiftness, certainty and proportionality.
- (7) Deliver services in natural environments (in the community), where possible, with a focus on the final outcome of recidivism reduction.




SUPERVISORY DEVELOPMENTAL COMPETENCIES

Supervisory development is a proactive and planned effort. Bargaining unit staff who are considering furthering their career in corrections or simply enhancing their skills, have an array of supervisory preparedness courses available to them within the ODRC. Supervisory skills encompass an array of competencies such as: project management, communication, decision making, problem solving, planning, delegation and meeting management, organizing teams, noticing the need for and designing new job roles in the group, developing staff, employee performance management and ensuring conformance to personnel policies and other internal regulations. A critical skill for anyone is the ability to manage their own learning. The highly motivated, self-directed employee can gain a great deal of learning and results from attending the SDC approved courses. Look for the SDC stamp which indicates courses that contain content specific to enhancing supervisory developmental competencies.

RULES AND REGULATIONS**

The following rules apply to all students, staff and visitors participating in CTA Training or Agency Sponsored Events.



1. Your state or agency identification badge must be worn while on state property and if walking on the Orient Correctional Complex grounds during or after class hours.
2. CTA student ID badges shall be worn during classroom hours.
3. Appropriate attire is required in accordance with the DRC Employee Grooming Policy 31-SEM-06. Shorts are prohibited. Additionally during physical skills instruction, the wearing of shorts is prohibited outside of the gym.
4. Mobile phones, pagers and all other electronic devices will be silenced during class.
5. Tardiness will not be tolerated.
6. Smoking and smokeless tobacco are prohibited on state property.
7. Parking in reserved, state vehicle, authorized staff spaces and no parking zones is prohibited.
8. Your CTA parking permit must be visible from inside your vehicle. (long term, more than 1 day)
9. In the event of a security related incident, cooperation with DRC investigative personnel or law enforcement officer is required.
10. CTA participants are prohibited from conversing with inmates within perimeter fences of neighboring correctional institutions and from photographing any features of these institutions inclusive of CTA or its firing range **and** any building of the Orient Correctional Complex.
11. Per DRC policy 310-SEC-09 & 37, all keys will be secured in a responsible manner. Loss of keys (personal or state issue) must be reported immediately to a CTA staff member.
12. All personal property, if not on your person, (cellular phones, purses, prescription medication, keys) must be secured during class either in your dorm room or the trunk of your locked vehicle.
13. Per DRC policy 310-SEC-04, employee personal weapons are prohibited on State property.
14. Acts or threats of violence (explicit or implied) will not be tolerated.
15. Possession of illegal or intoxicating substances and or being under the influence is prohibited.
16. All personal property and dorm rooms are subject to search at any time.
17. Students are not permitted in dorms between the hours of 8:00am and 4:00pm.
18. Dormitory quiet hours begin at 10:00pm and end at 6:30am.
19. Inappropriate conduct between students while on state property will not be tolerated.
20. Females are not permitted in Male Dorm Rooms and Males are not permitted in Female Dorm Rooms. You are required to be properly clothed at all times when in your dorm. Males and females may share the fitness room in the gymnasium and be properly attired at all times.
21. Bio-hazard Sharps disposal is the responsibility of the student and a container is located in the Sergeants office.
22. Before 8:00am on the day of departure, dorm keys are to be returned to the Sergeant's office and bed linens are to be left on the bed.
23. Recyclable items should be placed in the recycling containers located in the hallways and rooms of all buildings. (Cans, plastic bottles, paper). Food items are to be placed in trash cans.
24. CTA participants are expected to follow the aforementioned rules and the DRC Standards of Employee Conduct. Violations of any rules could result in discipline.




