RE: 2015 Annual Jail Inspection

Dear Sheriff Wasylyshyn:

In accordance with Section 5120.10 of the Ohio Revised Code and Executive Order 92-03 of the Department of Rehabilitation and Correction, the Wood County Jail, a full-service jail, was inspected on February 18th and 19th, 2016. The inspection was restricted to assessing compliance with a group of one hundred and fifteen (115) standards, selected from the Standards for Jails in Ohio promulgated by the Department of Rehabilitation and Correction. The group of standards being inspected focused on reception & release, classification, security, housing, sanitation and environmental conditions, communication, visitation, medical, food service, recreation, inmate discipline, administrative segregation, grievance, staffing, and staff training. The inspection consisted of this Inspector receiving and/or reviewing requested documentation and/or materials, touring selected areas of the jail, and having a brief interview with Jail Administrator Captain Gibson.

The total actual general housing capacity for the Wood County Jail is (220), consisting of (188) adult males and (32) adult females, (0) mixed (either adult males or adult females), and (0) special housing beds. On the date of the jail inspection, there were (122) inmates incarcerated in the Wood County Jail. The Ohio Department of Rehabilitation and Correction recommended housing capacity for the jail is (220), which is based upon total available living space and other requirements. Officials should maintain prisoner counts within the Department's recommended capacity figure.

The Wood County Jail (FSJ) is in compliance with the following standards:


