## AUDIT FINDINGS

### **Narrative:**

pre-audit- I reviewed each policy and compared the standard to insure each standard was met. I reviewed any reports that was sent.

audit- I met with the leadership team and explained the audit process and then requested a list of all staff and residents lists of who was present on that day and the next day. I toured the entire facility inside and outside. I went through every area including living units, food service, medical, offices, maintenance, closets and rec areas. I spoke with residents during the tour about PREA. I asked questions about training. I viewed the posters throughout the facility and noted my notice of this audit was posted. I reviewed the phones and the hotline number posted by the phones. I spoke with several staff about PREA and asked if they knew what it was and their responsibilities. I interviewed 14 staff and 9 residents that I had chosen, this included staff from all shifts. Several interviews included multiple areas as staff are responsible for different responsibilities of PREA. I reviewed resident and staff files looking for documentation of compliance. I spent 13 hours on site. I then conducted a briefing with the administrative team.

post audit-I went through all evidence I reviewed and all interviews and the started the report standard by standard insuring compliance.

## AUDIT FINDINGS

### **Facility Characteristics:**

SEPTA Correctional Facility is a regional community-based correctional facility housing 112 adult male felony offenders who are eligible for probation. Most residents are third and fourth degree offenders and have a history with the court system.

SEPTA Correctional Facility was created in response to the severe overcrowding of the state penal system. Residents are accepted into the minimum security facility from ten participating counties in Southeastern Ohio. SEPTA is fully funded through the Ohio Department of Rehabilitation and Correction and is locally governed by the SEPTA Facility Governing Board whose membership is appointed by the Judicial Advisory Board and the member county Boards of County Commissioners. The facility offers work release, education, counseling, chemical dependency, and community service. They have two units one is an open dorm the other is rooms. They can easily separate residents based on risk. They have an intake area with a couple of cells. They have an excellent food service area that provides 3 meals a day. All of the residents were very open and stated they were all aware of PREA and would report any issues to the supervisors or PREA coordinator. The staff at this facility are open and friendly and answered any questions asked. They have a great camera system. The administration was wonderful and very helpful. The facility head is retiring and she will be missed by staff. They all were very open and friendly with her. I want to thank everyone for their hard work and dedication to PREA.

	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	<p>The PREA Coordinator worked very hard to insure that all policies and practices were in compliance with the standards. He meets Quarterly to discuss and assure the facility is meeting requirements. He is instrumental in setting up several avenues for reporting abuse. He makes himself available to residents and staff to discuss PREA related issues. He sits in on the training given to staff and residents. He also insures residents are placed in the safest environment.</p>

	<p>This facility does not contract to house residents outside the facility.</p>

	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	The staffing plan takes into consideration the safety of residents and staff, the physical layout of the facility and the camera locations. The plan is reviewed yearly and whenever there is an incident. The facility administrators fill in and work when needed to assure the staffing plan is always in compliance. After every allegation of misconduct the staffing plan is reviewed.

	The facility follows all standards in the section. All staff are trained in searches, all 8 security staff interviewed and all staff I spoke with on the tour understood the policies on searches, announcing themselves and communication with transgender and non conforming residents. All staff and residents interviewed stated that residents can shower and dress without the opposite gender viewing them naked,

	<b>Auditor Discussion</b>
	The facility provides interpretive services when needed, If a resident cannot read the staff will help read and interpret all PREA related material. They do not use resident interpreters. All staff interviewed verified this information.

<b>115.217</b>	<b>Hiring and promotion decisions</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	The facility has a policy on Hiring and Promotions that states they will not hire or promote anyone who has ever engaged in sexual misconduct. They ask if the applicant has ever been criminally, civilly, or administratively convicted of sexual harassment or sexual abuse. They also contact previous employers for any information. They do back grounds prior to hiring and every five years or as needed. The staff are required to report any involvement with the criminal justice system immediately to the Executive Director. Failure to disclose will result in termination

	<b>Auditor Discussion</b>
	The facility has added new cameras to their system.

<b>115.221</b>	<b>Evidence protocol and forensic medical examinations</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	Every PREA compliant is fully investigated. I have reviewed all investigations and they are expertly done and followed correct investigative practices. Staff are trained to take initial actions and then Law Enforcement takes over when there is evidence of any type of abuse. Law Enforcement agrees to follow the national guidelines for PREA investigations. The facility has a MOU for victim services that will provide services at no cost to the resident. The local hospital has Safe/Sane staff on duty when caring for a victim. The facility has trained investigators for administrative investigations. I interviewed the investigators and they understood their responsibilities and knew that if it appears that any abuse happened or may have occurred they are to immediately turn over the investigation to law enforcement.

	<b>Auditor Discussion</b>
	All criminal investigations are referred to law enforcement, and administrative investigations are conducted by trained facility investigators. I reviewed all investigations and they were completed and appropriately handled. I reviewed the MOU and investigation policy to insure compliance. I interviewed the investigators. I also interviewed the one resident still at the facility who filed a complaint and he was satisfied by the outcome.

	<b>Auditor Discussion</b>
	All staff are trained in the zero tolerance policy, their responsibilities for prevention, detection, reporting, and response. The right that residents and employees have the right to be free from abuse or harassment. The dynamics of sexual abuse, and how to detect the signs, respond and report and how to communicate with non conforming residents, and how to comply with laws. This was evident in the interviews the employee training files and the resident housing files. While conducting the interviews of employees and residents they all understood the training and responsibilities.

	<b>Auditor Discussion</b>
	After reviewing training files and interviewing a volunteer I found that this standard was met. The volunteer stated she had been trained and was given the book "Games Criminals Play".

	<b>Auditor Discussion</b>
	The facility trains the residents immediately upon entry into the facility. They have posters through out the facility on how to report sexual abuse or harassment. The have signs posted by the phones on how and to whom they can report abuse. All residents stated they received information when they arrived at the facility. The PREA Coordinator normally gives the training to the residents. Then the case managers talk with the residents on a regular basis about PREA. They have an MOU for interpretive services. Staff will verbally help residents who cant read or are blind.

	<b>Auditor Discussion</b>
	All investigators are trained in the techniques for a proper investigation through the NIC investigators training.

<b>115.235</b>	<b>Specialized training: Medical and mental health care</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	Most aftercare is provided by an outside victim service. Staff are trained in the facility if the resident would prefer this type of service.

<b>115.241</b>	<b>Screening for risk of victimization and abusiveness</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The policy outlines the procedure for screening for risk of victimization and abusiveness. All offenders are screened within 48 hours of arrival. The tool is an objective instrument and follow up reviews are ongoing as long as the resident is at the facility. No one is disciplined for refusing to answer any of the questions. Upon reviewing the files all documentation was present. When I conducted the interviews with the residents they confirmed being asked those questions. There was some confusion on the 30 day reviews and how they were completed in a staff group the facility made the decision to have the rescreening done by the intake coordinator so that administrators have a smoother process and better information.

<b>115.242</b>	<b>Use of screening information</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	Policy states the facility will use the results from the PREA Screening Assessment to inform housing, bed, work, education, and program assignments with the goal of keeping separate those residents at high risk of being sexually victimized from those at high risk of being sexually abusive. Currently the information from the assessment is being used for housing, jobs and treatment. all staff that I interviewed understood the purpose of the assessments. All staff were trained and policy followed. I conducted a interviews with the case managers who state they use the screening information for placement in housing, programs and employment.

<b>115.251</b>	<b>Resident reporting</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	All staff are required to report immediately any knowledge, suspicion, or information regarding an incident of sexual abuse or sexual harassment that occurred in the facility, whether or not it is part of the agency; retaliation against residents or staff who reports such an incident; and any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation. All 16 staff interviewed were aware they were to immediately report any knowledge of sexual abuse or harassment. They can report their knowledge or suspicion of any allegations of sexual abuse to any supervisor, several staff stated they could also call the hotline. Everyone interviewed stated they would tell the PREA Coordinator.

<b>115.252</b>	<b>Exhaustion of administrative remedies</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	If a resident files a grievance about sexual misconduct then it is taken out of the grievance process and an investigation is started. If it is determined that there may have been sexual abuse then it is immediately turned over to law enforcement. If an outside source wants to report abuse it does not go through the grievance system it goes to the PREA investigators.

<b>115.253</b>	<b>Resident access to outside confidential support services</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	The facility has a MOU for victim services. This is described in the residents handbook, posters throughout the facility, training and interviews conducted of the residents. There is also a email system that staff, residents or the public can use to report allegations of abuse.

<b>115.254</b>	<b>Third party reporting</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	There are several ways for someone to report abuse. There is the website, posters, resident handbook and toll free number for reporting. Staff interviewed stated the residents could report verbally or in writing. They also stated that any 3rd party could also report abuse. Residents interviewed also stated the ways they could report.

<b>115.261</b>	<b>Staff and agency reporting duties</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	The policy requires staff report immediately all information related to sexual misconduct claims if they occurred inside the facility or from a different facility. All staff interviewed were aware of the directive and understood that the information is confidential. All 14 staff interviewed understand their responsibilities in reporting requirements.

<b>115.262</b>	<b>Agency protection duties</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	They have had no reports of a resident in imminent danger, But all 14 staff interviewed understood the procedures for keeping the residents safe and the correct reporting of this type of information.

<b>115.263</b>	<b>Reporting to other confinement facilities</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The facility head takes immediate action if she learns of an allegation of abuse at another facility. She will call immediately then follow up with a letter. After reportig she will cooperate with the investigation. She verified this through a interview and past memo's.

<b>115.264</b>	<b>Staff first responder duties</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	All security staff are considered first responders. Their responsibilities include separating the victim and abuser, preserve the crime scene, instruct the victim not to shower or do any bodily functions until law enforcement reaches the scene. All resident monitors interviewed stated they were first responders and could tell me their responsibilities related to this standard. The staff have been trained and I reviewed the training files.

	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	The facility has an excellent coordinated response that includes 1st responders, supervisors, evidence preservation, investigators, law enforcement, hospital care and victim services. All 14 staff who were interviewed understood how all teams work together to insure the safety of the resident and the proper investigations.

	<b>Auditor Discussion</b>
	N/A there is no collective bargaining

<b>115.267</b>	<b>Agency protection against retaliation</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	All staff have been trained in the policy against retaliation. I interviewed 2 of the staff who monitor retaliation and they both stated they monitor this for at least 90days after an allegation or longer if necessary. They stated they would immediately take corrective action and terminate the staff or remove the resident from the program if necessary.

	<b>Auditor Discussion</b>
	All investigations were done correctly and would be referred to law enforcement if administrative investigations determines a criminal act may have occurred. The investigations would continue if the staff or resident were no longer at the facility. All investigative reports are kept in a locked cabinet location for at least 5 years. Residents are not given polygraphs. All investigators are trained and documented.

	<b>Auditor Discussion</b>
	The policy only requires a preponderance of evidence, This was proven through policy review, reviewing investigations and interviews of investigators and administrations.

	<b>Auditor Discussion</b>
	The facility policy meets all requirements of the standard. Interviews with facility administrators knew the procedures for keeping the resident informed.

	<b>Auditor Discussion</b>
	The staff disciplinary procedures meet the standards. Most staff have resigned prior to the start of the investigation.

	<b>Auditor Discussion</b>
	The facility policy requires appropriate action if a contractor or volunteer has any sexual contact with the residents.

	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	I interviewed the Head nurse who outlined the requirements to first get the resident medical care for sexual abuse at no cost to the resident. She then stated they would let the resident know about any sexually transmitted infections. Security staff would be notified immediately and the facility has an MOU with an outside provider for victim services. All staff stated they would provide the same services for those that identified the abuser or not.

	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	All necessary medical and mental health services are provided through MOU's. Administrators and Medical staff work together to address sexual abuse or harassment cases. The coordinated plan outlines procedures to follow to insure compliance.

<b>115.286</b>	<b>Sexual abuse incident reviews</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The facility will conduct a review of all sexual abuse incidents within 30 days. The review will look at policies, practices, motivations by abuser, the physical lay out of the area, staffing levels and video monitoring to determine if any changes need to occur. All actions will be documented. I reviewed the after action reports and interviewed the administration and all documentation was appropriate.

	<b>Auditor Discussion</b>
	The agency reviews all the data yearly and makes changes to policies, staffing or building modifications necessary to reduce sexual abuse. The review all problem areas and prepare an annual report. They also send a quarterly report to the state of Ohio.

	<b>Auditor Discussion</b>
