

**Average Time Served Among Ohio Prison Releases, Calendar Year 2016\***Executive Summary:

This report represents data on the number of releases and average time served by legal mechanism of release, gender and offense type. Table 1 summarizes average time served for all offenses and all releases (including judicial releases) sorted by sex and felony level. Tables 2 through 7 present detailed breakdowns by release type. Inmates released through transitional control are counted only after expiration of stated term or release to parole/PRC during CY 2016. The CY 2016 time served summary numbers are based on 19,601 non-judicial releases, representing a 4.22 percent increase in these exits from CY 2015 (18,807) to CY 2016. Highlights from the report are summarized below:

- The average time served in CY 2016 among non-judicial releases was 2.59 years, representing a 4.43% increase from CY 2015 (2.48 years). Historical patterns in time served averages are shown in the table below.
- Parole releases accounted for 64 of the 19,601 non-judicial releases. Their overall average time served increased from CY 2015 (21.05 years) to CY 2016 (24.38 years).
- Releases onto PRC increased from 9,348 in CY 2015 to 10,256 in CY2016, an increase of 908 or 9.71%, representing 52.3% of all non-judicial releases. Slightly less than half of the releases (49.7%) went on PRC in CY 2015. Correspondingly, EST releases represented 46.8% (a decrease from 49.6% in CY 2015) of those releases.
